Each of Hainan Cares and Xiamen Cares has the necessary qualifications, capabilities and technological skills required to carry out the relevant works as specified under the Hainan Cares Subcontract Agreements and the Xiamen Cares Subcontract Agreements, respectively. The Board is of the view that it will be for the benefit of the Company to subcontract to Hainan Cares and Xiamen Cares the relevant work as specified under the aforementioned subcontract agreements.

The Directors (including the independent non-executive Directors) are of the view that the transactions under the Hainan Cares Subcontract Agreements and the Xiamen Cares Subcontract Agreements will be conducted in the ordinary and usual course of business of the Group and on normal commercial terms, and that the terms of the transactions are fair and reasonable and in the interests of the Company and the Shareholders as a whole.

#### IV. IMPLICATIONS UNDER THE LISTING RULES

Hainan Cares is a non-wholly owned subsidiary of the Company, which is owned as to 22.74% by Southern Holding, a substantial Shareholder of the Company as at the date of this announcement. As Southern Holding directly holds interests in more than 10% shareholding in Hainan Cares, Hainan Cares is a connected person of the Company under the Listing Rules. As such, the transactions contemplated under the Hainan Cares Subcontract Agreements constitute connected transactions of the Company.

Xiamen Cares is a non-wholly owned subsidiary of the Company, which is owned as to 51% by the Company, 28.5% by Xiamen Airlines Company Limited\* (廈門航空有限公司) and 20.5% by Xiamen International Aviation Company Limited\* (廈門國際航空港股份有限公司). Xiamen Airlines Company Limited\* is a subsidiary of Southern Holding and Southern Holding is a substantial shareholder of the Company as at the date of this announcement. Xiamen Cares is therefore a connected person of the Company under the Listing Rules. As such, the transactions contemplated under the Xiamen Cares Subcontract Agreements constitute connected transactions of the Company.
